Cyberport.hk INCUBATION PROGRAMME

- **Duration of programme:** 24 months
- Financial assistance/re-imbursement: HKD 530 000
- Acceptance policies:
 - o Applicants must have viable business plan for product/service to be ready for marketing in 12-18 months
 - o Must have sufficient funds/plans to raise sufficient funds, for company to operate for at least 1 year upon admission to Incubation Programme
 - o Incorporated business entity before admission (not mandatory as Programme aims to help start-up business, but Incubatee must be company registered and incorporated in HK upon admission)
 - o Projects:
 - Rooted in ICT-related areas
 - Must not have received & will not receive funding granted by other publiclyfunded organizations/programmes that provide similar stage of business development like Cyberport
 - o Applicants must make:
 - True & accurate disclosure of proposed/similar ICT projects participated in other publicly and/or privately funded programmes including/not limited to:
 - All applications in progress to process
 - All admissions to such programmes
 - All grants/funding received by Applicant (or any company established by
 A) in past 18 months prior to date of submission of IP application & scope
 of expenditure for such grants/funding
 - All grants/funding which A (or any company established by A) anticipates to receive/entitled to receive in 18 months after submission & scope of expenditure for such grants/funding
 - o Provide evidence of payments made/received
 - o Inform Cyberport immediately if there are subsequent changes to above information

Application procedure:

- o 1 hardcopy of completed form, plus an online Incubation Programme application submitted
- o Initial screening by Cyberport Entrepeneurship Centre
- Application Vetting Team:
 - Considers following:
 - Quality and competence of management team (20%)
 - Creativity and innovation of proposed project, product or service (20%)
 - Market and business viability (30%)
 - Benefit to HK ICT industry (10%)

- Proposed 6 monthly milestones for project/business after admission (20%)
- Final funding decision subject to Vetting Team's eval no appeal/request for explanation of decision will be considered

 - o Through ITC, Government hopes that HK companies can be encouraged and assisted to upgrade technological level and introduce innovative ideas to business

SMALL ENTREPENUER RESEARCH ASSISTANCE PROGRAMME (SERAP):

• Eligibility to apply:

- o Incorporated in HK under Company's Ordnance
- o Has less than 100 employees in HK
- o Not large company
- o Not subsidiary of/or significantly owned/controlled by large company

• Financial assistance: Up to HKD 6 million

o Provided on dollar-to-dollar matching basis to successful applicants to undertake 2 year R&D project for bringing innovation & technology to pre-market launch stage

• Application procedures:

- o Submitted electronically through Innovation and Technology Commission Funding Administrative System (ITCFAS) at ITF website
- o "A" (Applicant) required to register organisation and relevant personnel prior to submitting application proposal
- Project coordinator & deputy project coordinator needs to be employed by A company at time of application & throughout project period
- o Original ideas for proposed project without any constituted/potential act of infringement
- o Meeting with A and/or conduct visit(s) to A's company
- o Vetting of application:
 - ITC may seek comments & advice from outside experts
 - Applications & supporting documents submitted to Panel
 - Panel meetings held every month

Assessment Framework:

- o Innovation and technology component (30%)
- o Commercial viability of project (30%)
- o Team capability and commitment (30%)
- o Relevance with Government policies/in for other Government funded projects (10%)
- **Processing time:** 50 clear working days

ESS:

- Major funding initiative under ITF designed to encourage private sector to invest in R&D
- Aim:
 - o Create 'rainforest' of technology start-ups
 - o Increase private sector investment in R&D
 - o Attract Mainland & foreign companies to establish R&D presence in HK
 - o Create more technology-related jobs
- Financial assistance: HKD 10 million by dollar-to-dollar matching basis
- Main Features:
 - o **Project period**: No longer than 2 years
 - o Funding recipient company will own all intellectual property rights arising from project
 - o Recoupment of Government's contribution is not required
 - o Benefit sharing of commercialised R&D results non-mandatory
 - o Project with an approved project period of 12 months or longer can apply for financial assistance under the **Internship Programme** to hire additional staff.
 - o Each project can hire up to 2 interns.

o The funding recipient company can also apply for **the Research and Development Cash Rebate Scheme** to receive a cash rebate of up to 30% of the company's expenditure in the project.

• Eligible to apply:

- o Incorporated/registered in HK under Companies Ordnance
- o Not Government subvented organisation
- o Not subsidiary of any government subvented organisation
- Applications submitted throughout the year
- Application process:
 - o Application received
 - o Secretariat to seek clarification of project/supplementary info from A
 - o A submit revised application
 - o Application vetted by Project Assessment Panel
 - o Notify A of result

HKSTP INCU-APP:

- Acceptance policies:
 - Must be HK registered technology start-up company established no more than 2 years before date of application
 - HKSTP may request proof including/not limited to audited financial report of company
 - o Founding members:
 - Must not hold more than 50% of company at time of application submission
 - Must be individual share holders/non-operating holding companies (reflected by Articles of Association/any other valid proof)
 - Minimum one full time staff
 - o All staff must be able to work in HK legally
 - Team of full-time engineers & technologists must:
 - Individually/collectively own at least 10% of company equity
 - If have university equipment & applicant is approved by said uni, any shares held by founding uni prof/s counts as 10% equity
 - o <50% full time staff must be engaged in tech work
 - o Implementation of R&D activities at Incubation Centre cannot operate sales & marketing office only
 - o No retail activities/massive production
 - o Applicant's office & workbench set up at Incubation Centre must be environmentally friendly (no smell, noise or other elements that'll disturb others)
 - No hazardous materials
 - Should operate in office building
 - o Requirement less than 1600 square feet office space
- **Duration of program:** 18 months
- Aim:
 - o Provide support to web/mobile application technology start-ups
 - o Allocated well-furnished office space in **Incu-App Centre**
 - Entitled of up to 2 assigned workstations free of charge during incubation period
 - Workstations include desk area with partitions, chairs and locker
 - 1st workstation: free
 - 2nd workstation: free

- 3rd workstation onwards: HKD 3180/mth
- Applies to companies with:
 - Web-based applications
 - Smartphone-based applications
 - o PC/internet/smartphone/console games
- **Processing time:** 26 working days

HKSTP INCU-BIO

- **Duration of program:** 4 years
- Aim:
 - Designed for biotechnology start-up companies that need wet lab environment for operations
- **Applies to companies:** Engaged in biotechnology including:
 - o Therapeutics/personal care
 - Chinese or Herbal Medicine
 - o Regenerative Medicine
 - o Medical Devices
 - o Diagnostics
- Acceptance polices:
 - o Applicant must be HK registered technology start-up company established for no more than 2 years before date of application
 - HKSTP may request proof including & not limited to audited financial report
 - o Founding team members must not hold more then 33% company at time of submission
 - o Founding team members must be individual shareholders or non-operating holding companies
 - o At least 2 full-time staff in company
 - o All staff must be able to work in HK legally

- o Team of full-time engineers & technologists must, individually/collectively own at least 10% company equity
 - If applicant has tech from uni & approved by said uni, any shares by founding uni prof(s) shall count towards 10% equity ownership requirement
- o <50% full time staff must be engaged in technology related work
- Implementation of R&D activities at Incubation Centre cannot sales & marketing office only
- o No retail activities/massive production at Incubation Centre
- Applicant's office & workbench must be environmentally friendly (no smell, noise, other elements which may disturb others), operate in office building and not handle hazardous material
 - Except in wet labs of Biotechnology Small Enterprise Centre adhering to HKSTP published safety standard & guidelines)
- o Normally, a shareholder working for the applicant cannot be a shareholder or former shareholder who is working for or worked for any of the following:
 - (i) more than two other companies in the same field as applicant that have previously joined and failed to graduate from any incubation programme operated by HKSTP, Hong Kong Cyberport Management Company or Hong Kong Design Centre (together the "HK Incubators");
 - (ii) a company in the same field as applicant that has previously joined and graduated from any incubation programme operated by any of the HK Incubators; or
 - (iii) a company in the same field as applicant currently in any incubation programme operated by any of the HK Incubators.

o **NOTE**:

- In case of successful application, applicant needs to fulfill the admission criteria throughout the incubation period, and maintain at least 2 full-time staff members at the office at Hong Kong Science Park Technology Incubation Centre, where they should conduct the core R & D.
- The applicants should have full disclosure of shareholder's identity and holding (up to the top level) of applying entity. The general guideline is that should there be corporate shareholders, they should not be mature companies in the same industry involving R & D of the same or similar products.

- o Milestones set for every 6 months after move in

DESIGN INCUBATION PROGRAMME

- **Duration of programme:** 2 years
- Application policies:
 - o Local applicants:
 - HK PR
 - His/Her Company as start-up HK incorporated company
 - No more than 3 years as of date of application
 - Still in early stages of development
 - Must have as of date of application & throughout incubation period at least 2 fulltime staff
 - 1 must be shareholder/partner & designer in recognised design discipline & HKPR
 - Aggregate share holdings controlled by above said full-time designer's should be majority
 - o Overseas applicants:
 - Overseas incorporated company operating in country of domicile
 - Not incorporated more than 5 years as of date of application
 - When approval granted, A (Applicant) must set up HK incorporated company immediately to qualify for programme commencement
 - Must have at least 2 fulltime staff
 - Representative from his/her country working in HK Incorporated company before commencement of programme
 - Must be designer/professional with design knowledge in recognized design discipline
 - o Qualify for OFFICE RENTAL & BUSINESS CENTRE ASSISTANCE:
 - Not require more than 650 square foot gross of office space at time of admission/general
 - Shareholder/partner of A company must not be share-holder/partner of current incubatee/graduated company in DIP, or any incubation programmes funded by HK SAR government
